- i) One (1) no of Water management (sub contract) amounting to Rs 79.33 millions
- ii) Four (4) Road projects amounting Rs 120 millions
- iii) Irrigation project amounting to Rs 1630.73 millions

All the above new projects bagged by the company highlights of the continued approach of bagging new orders indicating likely robust growth in reverse in coming months.
